# Webtrade Respects Each Individual's Right to Privacy.

We know how important it is for us to safeguard any personal information that may reveal your identity or account information, whether you are our client or a visitor to our Web site's public domain.

#### **Your Privacy is Our Priority**

Webtrade is committed to its privacy obligations under the National Privacy Principles contained in the Privacy Act 1988. This privacy policy describes how we handle and protect personal information we collect about individuals who apply for or receive our products and services.

#### **How We Collect Personal Information**

# **About Cookies**
